
Legislature Update:

A **clerk** is a senior official of many municipal governments in the English-speaking world. In some communities, the position is elected, but in many others, the clerk is appointed to their post. In almost all cases, the actual title of the clerk reflects the type of municipality he or she works for, thus, instead of simply being known as the *clerk*, the position is generally referred to as the **town clerk**, **city clerk**, **village clerk**, or **county clerk**. Other titles also exist. The office has existed for centuries, though in some places it is now being merged with other positions.

The duties of a municipal clerk vary even more than their titles. Particularly in the United States, it is impossible within the scope of this article to fully describe a clerk's duties, because there are literally hundreds of different job descriptions extant. In some U.S. states, there are provisions in the state constitutions delineating the clerk's duties, but in other states, each municipality decides for itself what role the clerk plays, or even, if there need be a clerk at all, the clerk's duties, but in other states, each municipality decides for itself what role the clerk plays, or even, if there need be a clerk at all.

WORKPLACE VIOLENCE EDUCATION

PROVIDED BY: KIRKSVILLE POLICE DEPARTMENT

At the Missouri City Clerks and Finance Officers Association Spring Conference this year, I heard an education session by the City Clerk of Kirkwood, Missouri regarding the tragedy that struck the City of Kirkwood three years ago. Two police officers and three city officials were shot and killed on the night of a Kirkwood City Council meeting, plus one more death weeks later, as a result of a gunshot wound from that same night. The shooter was a man who had received 150 tickets for code violations over a period of time, and who made regular visits to Council meetings, before opening fire at a Council meeting. Kirkwood's City Clerk explained what security they had in place prior to the incident, but also what steps they took afterwards.

As the City Clerk of Kirksville (population 17,300), I understood the importance of educating city employees on workplace violence. I took the first step by sharing my thoughts with the City Manager to obtain support to proceed. My next step was to ask our Police Chief to hold an informational presentation with office personnel and supervisors regarding workplace violence. Our Police Chief was outstanding - He explained warning signs, such as verbal threats - "you'll be sorry"; the meaning of bizarre and delusional behavior - Example: If people feel they are entitled to a lower bill, then they see that customer service person as the one who is blocking them from their entitlement; degrading and humiliating others - if this person sees you as unimportant, why wouldn't they kill you?; and repeated violations of city policies and ordinances.

He offered us three options if an active shooter were present: You can hide. You can run. You can fight. There are pluses and minuses on each of these because it depends on the circumstances. If the shooter is shooting randomly, then hiding could be safe. If the shooter is taking his time and looking for people, then hiding may not be a good choice. If you run, then you become a moving target which makes the shooter want to turn and aim at you. On the other hand, you may have a chance by running to escape; it depends on how close an escape door is and how fast you can run. To fight also places you at danger to be shot. But fighting as a group could be the best option.

Homicide is the fourth-leading cause of fatal occupational injury in the United States. The Police Chief repeatedly told us there is no difference between suicide and homicide because anyone who is thinking about or contemplating suicide will not think twice about killing someone else.

Our Police Chief encouraged each city department to come up with a plan of escape. The City Council has received training on possible violence, and the danger they are placed in by meeting in a room for a work session that does not have but one door. The Council has chosen to continue to meet in this room. It is my hope that they will reconsider for their safety and others who are in attendance.

To continue our education on workplace violence, we will hold another meeting with office personnel to be conducted by a Police Officer who has been trained on violence in businesses.

Feedback from the attendees was excellent. All departments shared information about individuals who they have dealt with who lined up with some of the warning signs. One name in particular was brought up by different departments, but not everyone knew that others had dealt with this person. Therefore, we plan to communicate with other departments when someone presents themselves as questionable. On the day of the meeting with the Police Chief, our Water Department personnel had received an e-mail from a water customer who was threatening suicide although this same person has done this before. This is an example of a person who could also commit homicide.

What happens next: Each City department will come up with a plan for escape. We will communicate information on questionable people between departments. More educational training will be scheduled.
