The Nominating Committee invites members to complete and submit a Statement of Interest form for consideration to serve as an officer for the year beginning May 1, 2018 through April 30, 2019. It is the responsibility of the Committee to prepare a slate of at least one candidate for each office for election at the annual business meeting that will be held at the Spring Institute in March 2018.

The positions that are open are President-Elect, Secretary and Treasurer.

The Association by-laws state that the President Elect automatically moves up to President while the other positions require a Statement of Interest. In order to be considered for an office, a member shall have completed at least one of the following in addition to having attained CMC or MRCC designation:

1. Have attended at least four (4) MOCCFOA Spring Institutes.
2. Be or have been an officer in a local division.
3. Previously held the position of Director.

Candidate for Treasurer must have served one year on the Budget Committee.

Division Directors from the Central, Northwestern, East Central, Southeast and Eastern will also be open. The Directors from these listed Divisions will serve a 2-year term from May 1, 2018-April 30, 2020.

The Association by-laws state the Division Director in addition to having attained CMC or MRCC designation shall:

1. Have attended at least one (1) MoCCFOA Spring Institute.
2. Be an active member of the division they represent for a minimum of 2 years.

It is the responsibility of each division, whose director's term is up, to present to the Nominating Committee their nomination for Division Director to be presented for approval by the membership at the annual business meeting at Spring Institute in March 2018.
